ASEM - Mapping and Assessing the European Mobility Advisor (EMA), is a project cofunded by the Erasmus+ Programme of the European Union - KA2 cooperation for innovation and the exchange of good practices.

The objective of the project is to develop a methodology for the assessment of the EMA, a youth worker (or youth educator or youth career counselor), specialized in advising young people willing to go abroad for a learning experience, either by studying, working or volunteering. Asem will improve the current situation by mapping the competence profile of the EMA at European level, and by developing a methodology for assessment of their competence called "Expertise checkup", a E-training course for assessors, a European certification and a register for EMAs.

The consortium is composed by organizations working with youth mobility in France, Latvia, Slovakia, Poland and Italy and can rely on a wide European network.

Approximately over 400 EMAs will be involved in the project and 10.000 youth workers will be informed about the project.


Long term benefits will be the professionalization of the EMAs, and delivery of better quality mobility guidance.

KERIK is a youth based non-profit and non-governmental organization in the region of Kysuce - north Slovakia. The mission of the organization is to connect the Kysuce region with Europe and the rest of the world, and to help people from the region become more open and tolerant towards other cultures. The main aim of KERIK is to provide space for young people to implement their ideas and receive education in a non-formal way during their spare time. Every year, around 250-300 young people take part in regular activities promoted by KERIK on a weekly basis (courses, workshops), and between 300 - 600 on an irregular basis (information campaigns, outdoor trips, street activities, summer camps).



## 2 - 1st TRANSNATIONAL PROJECT MEETING

During the past 15th and 16th of January 2020, the City of Bastia (Corse, France) has hosted the 1st Transnational Partners meeting of the ASEM project. Members of the consortium - coming from France, Latvia, Slovakia, Poland and Italy - have gathered together in order to discuss in depth the main project objectives, milestones and task distribution for the next months to come. Each organization did a short presentation about the activities they run in their countries, and their motivations and expectations about the project. Some of the organizations are directly involved in European information, some others are dealing with European projects such as work camps and European Solidarity Corp. In the afternoon we went through each work package and we agree in general on the work process. The consortium agreed about the way the first WP, which is about the profile of the European Mobility Advisor, will be created. The focus will be very general trying to include the different aspects of the information work, but also the peculiarities of each organization involved.
